# FISHING-RULES 2025

## Welcome to Beiarn-river!

The fishing for salmon and sea trout is opened at parts of the Beiarn-river that's affiliated to Beiarelva SA. From the lower part of the fishing ladder at Tollåga and Hauforsen, and the following 50 meter, fishing is forbidden. Above the fishing ladder at the Tollåga-river, fishing is forbidden (at the anadromous-zone).

### The Fishing season:

**Salmon:** 15.06 - 31.08.

**Sea trout:** 15.06. - 31.08, throughout the river. And below the Storjord-bridge from 01-14.09.

**Arctic char:** Fishing for Arctic char is not allowed (To be released)

**Fishing day\*:** From 6:00 a.m. to midnight (except opening day)\*

\***The opening day:** "Fishing starts at 12:00 on 15.06 and lasts until 06:00 on 16.06.

\***Opening hours:** Half-day passes last from 12:00 > 21:00 and 21:00 > 06:00 the next morning. At the zones Tvervik, Arstad/Dokmo, Soløy, Moldjord and parts of Vold (Storøyra) up to the high-voltage line that crosses the Beiarelva and the border Kvæl - fishing is possible 24 hours a day throughout the season. At low water levels below 7m<sup>3</sup>/sec, the board will consider closing the river.

### Salmons: Catches, quotes and minimum size

**Salmon:** Daily quota is 3 salmon, where only one salmon under 65 cm can be killed per fisherman.

**Seasonquota:** 4 salmon under 65 cm per fisherman.

All salmon above 65 cm- and under the minimum size of 40 cm must be released

**All injured and killed salmon above 65 cm and under the minimum size of 40 cm must be reported and delivered to the landowner, and reported to the catch-report**

Farmed salmon must be killed throughout the season regardless of quotas.

Farmed salmon that has not been presented fishing card seller/local seller shall be deducted from the quota. Only the card seller or the person/people determined by Beiarelva SA, confirms what is farmed salmon. Farmed salmon does not count towards the quota and is kept by the fisherman after it has been presented. Incorrectly assessed fish are handed in to the landowner/fishing card seller.

### Seatrout: Catches, quotes and minimum size

**Sea trout:** Daily quota: 3 sea trout under 60 cm

**Seasonquota:** 10 sea trout under 60 cm per angler

All sea trout above 60 cm and below 40 cm must be released.

All sea trout over 60 cm- and under the minimum size of 40 cm must be released

**All injured and killed Seatrout above 60 cm and under the minimum size of 40 cm must be reported and delivered to the landowner, and reported to the catch-report**

### Bait and gear

- Fishing with gear that has up to one triple hook is permitted.
- It is recommended to fish with hooks without barbs
- The use of small but strong hooks with small barbs is encouraged (may cause less damage to fish)
- Fishing with worms is permitted
- Fishing with one rod per fisherman is permitted, and the fishing rod must not be abandoned while fishing
- The use of electronic fish-finding equipment is prohibited
- The use of a jig is prohibited
- Fishing with flies and sinkers is prohibited
- When using flies and floats, the floating float must constitute the casting weight

### Rule change for the Beiarn river.

- 1: **Purchasing multiple cards** in your own or someone else's name in the same zone/on the same day is considered illegal.
- 2: **Subletting or reselling fishing cards** that do not include agreements entered into before the start of the season with the landowner is considered illegal.

### Other fishing rules

- A receipt for the paid fishing fee must be presented to the card seller when purchasing a fishing license and disinfection.
- All equipment, including boots/waders, must be disinfected before permission is granted to fish in the Beiarelva River and salmon-bearing tributaries regardless of where the equipment was last used. This requirement also applies to canoes/ boats, packrafts or other equipment used in the river.
- Disinfection certificates from other rivers are not valid in the Beiarevassdraget.
- Mobile fishing downstream is mandatory.
- Both killed and abandoned fish must be reported on the card within 1 day.  
"Zero catch" must be reported
- All damaged and therefore killed fish above the maximum size or below the minimum size must be reported immediately to the card seller at the given phone number via SMS immediately.  
The fish must be presented and handed over to the landowner/card seller
- Shell-samples must be taken from all salmon and farmed salmon that are killed.
- Fish that are released back into the river must be treated as gently as possible to avoid mortality.  
They must never be taken out of the water.
- All fishermen must use long-beaked pliers when removing hooks, and have access to a knotless net
- It is recommended to measure- and mark the fishing rod at 65 cm.
- Significant violations of the rules can be reported to the salmon office. See attached consequences for violations
- It is not allowed to fish from floating vessels such as canoes, boats, packrafts
- Receipt for disinfection fee must be carried when fishing
- Downstream mobile fishing based on rotation is required

## CONSEQUENCES BY BREAKING RULES, BEIARN RIVER

By fishing the Beiarn river you accept the fishing rules and comply with them. Breaking the rules is punishable and can lead to a police report (this according to the salmon- and inland fishing Law).
